# **CoCreate Privacy Policy**

Entity: CoCreate Digital, Inc., a Delaware C-Corporation ("CoCreate," "we," "our," or "us").

Your privacy is important to us. This Privacy Policy explains how we collect, use, share, and protect your information when you use CoCreate. By using our platform, you agree to the terms of this Privacy Policy.

#### 1. Information We Collect

We collect the following types of information:

#### a. Information You Provide

- Account details (name, email, password, profile info)
- Payment details (processed securely by third-party providers; we do not store full payment info)
- Content you upload (posts, messages, profile updates)

#### **b. Information Collected Automatically**

- Device information (IP address, operating system, app version, device identifiers)
- Usage information (features used, interactions, connections made)
- Cookies and tracking technologies (to improve functionality and analytics)

#### c. Information from Third Parties

- If you sign up via Apple, Google, or LinkedIn, we may receive profile information (such as email or profile name).
- Payment processors (Stripe, Apple, Google) provide us with transaction confirmations.

#### 2. How We Use Your Information

We use your information to:

- Provide and improve the CoCreate platform
- Personalize your experience (suggest connections, content, opportunities)
- Process payments and manage subscriptions
- Ensure safety and integrity (detect and prevent fraud, abuse, or violations)
- Communicate with you (updates, support, offers, policy changes)

### 3. How We Share Your Information

We do not sell your personal data. We may share information in the following ways:

- With other users: Information you choose to share (profile, posts, messages) will be visible to others on the platform.
- With service providers: Third-party partners (Stripe, Apple, Google, Firebase, analytics tools) help us operate the platform.
- **For legal reasons:** If required by law, regulation, or to protect the rights, safety, or property of CoCreate or others.
- In business transfers: If CoCreate is involved in a merger, acquisition, or sale of assets, your data may be transferred.

### 4. Your Choices & Controls

Access & update: You can update your account info at any time in your profile settings.

- **Delete account:** You may delete your account, after which we will delete or anonymize your data except as required by law.
- Cookies: You can adjust your device or browser settings to manage cookies and tracking.
- Marketing emails: You can opt out of promotional communications via unsubscribe links.

#### 5. Data Retention

We retain your personal information as long as necessary to:

- Provide the platform
- Comply with legal obligations
- Resolve disputes
- Enforce our agreements

If you delete your account, we will delete or anonymize your data within a reasonable period, unless required to keep it.

## 6. Data Security

We use technical and organizational measures to protect your data. However, no system is 100% secure. You use CoCreate at your own risk.

### 7. Children's Privacy

CoCreate is not intended for individuals under 18. We do not knowingly collect information from children. If we learn we have collected information from someone under 18, we will delete it.

### 8. International Users

CoCreate is based in the United States. If you access CoCreate from outside the U.S., your data will be transferred to and processed in the U.S.
